PRESIDENT'S MESSAGE



Dear Members and Friends,

Our Kentucky Architecture, Engineering, and Interior Design offices continue to be busy with an abundance of work! I hope each of you are finding success in this economic boom. Did you know nationally there are more than 120,000 licensed architects and many hold licenses in multiple states? The majority of our licensees do not live in the Commonwealth and received their license to

practice here through reciprocity. NCARB is a leader among all professions in reciprocal licensure and continues to evolve with progressive alternative paths to licensure while maintaining the health safety and welfare of our citizens. In Kentucky we cannot recall a particular case in which a licensee without a NAAB degree had a serious complaint filed against them.

The traditional and the only path in Kentucky for an initial license is to obtain a NAAB accredited bachelors or master's in architecture, complete the AXP experience program, and take the full Architecture Registration Exam. Nineteen states now allow a combination of education and experience to replace the NAAB accredited degree. Over 45 states including Kentucky will give a reciprocal license to those individuals once they receive an NCARB certificate. NCARB is navigating the ever-changing rules, statutes, and regulations of the 55 jurisdictions which are member boards, as well as the international licensure agreements.

Many of us work alongside someone who doesn't have a NAAB degree yet is fully competent. Our offices are looking for more people to fill positions. Kentucky has one NAAB accredited program for architecture. National statistics indicate that with our population we should have two NAAB accredited programs. Several lifetime Kentucky residents working in architecture have received licenses in other states, just so they can eventually practice here in Kentucky via reciprocity. Our board is looking at how we can best accommodate our Kentucky citizens and break down unnecessary barriers to licensure while supporting the health, safety, and welfare of our population. Please reach out to me, other board members, or our board staff to let us know your thoughts while we explore alternative paths to licensure.

BOA SPOTLIGHT



KENTUCKY'S FIRST CID Peggy Sharon

In 1979, Peggy became Kentucky's first person to be an CIDQ certificate holder and when Kentucky passed title legislation, she became the first certified interior designer, 0001CID. Since her initial involvement, she has maintained continuous active status with both regulatory bodies. She was appointed as the first interior designer to the Board of Architect, and faithfully served from 2003-2015. Peggy is a graduate of Eastern Kentucky University with a Bachelor of Science degree in Interior Design/Industrial Design, and the University of Kentucky with a Master of Arts degree in Interior Design/Preservation and a Doctor of Education degree with Architecture as the specialization. Throughout most of her career, she maintained active professional status in ASID, IIDA, and IDEC.

Peggy has received numerous professional recognitions such as the 2014-2015 VIP of the Worldwide Who's Who Registry of Executives, Professionals, and Entrepreneurs; 2006 Presidential Citation for Distinguished Service to the American Society of Interior Designers; 2002 Bluegrass Tomorrow Vision Award for a "New Urbanism" Interstate Development design; 2005 and 2012 Council for Interior Design Qualifications Recognition of Outstanding Service to NCIDQ; and in 2004 Recognition for being a Charter Member of the International Interior Design Association. In 1986 she was recognized and awarded a national grant for research on design education by the Institute of Business Designers, the predecessor to IIDA. She has a passion for the interior design profession and has worked diligently to increase the level of professionalism to strengthen the educational path for certification on both the state and national levels through legislation and the NCIDQ examination.

Since 2009, Peggy has been the owner of Sharon Associates, LLC, an Interior/Environmental Design and Real Estate Consulting business in Midway, Kentucky. Her work goals are "Designing Spaces for Living that encourage positive physical and mental health, and social interaction." She credits her father, Leslie M. Sharon, a craftsman in his own right, for inspiring her passion for design at an early age.

Laura Leach Van Vactor is the Director of Design-Build at ABEL Construction Company Inc. and a former Assistant Professor of the Department of Architectural and Manufacturing Sciences at Western Kentucky University. She graduated with a Bachelor of Science in Industrial Technology, Architectural



Design and Construction at Western Kentucky University, and a Master of Architecture from Texas A&M University. Laura is a registered architect in Kentucky, Indiana, and Tennessee; commissioned as a member of The Honorable Order of Kentucky Colonels; National Association of Women in Construction (NAWIC) as a former board member; and Habitat for Humanity as a former construction manager, volunteer manager, and fund-raising manager. She is a member of the following organizations: (Kentucky, Indiana, Tennessee) Board of Architects; National Council of Architectural Registration Boards; National Association of Women in Construction; Design-Build Institute of America. Laura has traveled across the country presenting at conferences and workshops. She has also received numerous grant awards and publications on community engagement via architectural education. During her spare time, she enjoys horse competitions, crafting, and spending time with her family and lifelong friends.

What is the best advice you would give someone who just started their architecture career?

The best advice I could give someone just starting their career in architecture is to never let anyone stand in your way to becoming a licensed architect. There is a path for everyone, and we need all types of people in the field to be able to produce great works of architecture. This works both ways, but the brilliant 'design' oriented person may not know how to keep the water out, or how to handle line of sight issues with restrooms, the best location for the coffee pot, or a multitude of other problems that all need solving in order to create a truly great work of architecture. There is room, and a need for all of us.

What do you love most about your profession?

Architecture evokes an emotional response from people. Through Design, we can spark joy in learning as we do in Children's Museums, or depress the human spirit as we do in a prison, and everything in between. Architecture is a reflection of who we are as a people; what we believe in, our history, our politics, and our priorities as humans. To me, Architecture is everything, and I am thrilled every day to be a part of creating it.

If you could learn to do anything, what would it be? If I could learn to do anything, it would be on how to become an inspirational speaker. Never let anyone hold you back or create a roadblock for you. If you are determined, there is a way.

KY BOARD OF ARCHITECTS BOARD MEETING



After taking care of customary board business and standard reports, Mr. Beyer reported on the CIDQ Annual Meeting that he, Ms. Smith, and Ms. Harbut attended in Louisville. He informed the Board that CIDQ was working to generate new model legislation to help member boards in updating their laws. He also stated the proposed governance structure change was voted down and CIDQ is currently reviewing their practice analysis to ensure their testing and functionality stay current with industry standards.

When the Board moved to new business, one of the items that caused a lot of discussion was the Multiple Paths to Licensure topic. Ms. Smith said she thought the push for alternative paths was coming from NCARB's president Jon Baker, a successful architect in California. He is the first NCARB president within the last 30 years with only a high school education that took a nontraditional path to licensure. She noted individuals outside of Kentucky can obtain a NCARB certificate through reciprocity without a NAAB degree; however, Kentucky residents must obtain a NAAB degree before being licensed. There was discussion around licensing individuals with degrees from schools and colleges accredited by SACS (Southern Association of Colleges and Schools) rather than NAAB as the statute requires. Mr. Johnson expressed concern that there were vast differences in the 4-year degree programs throughout the state and questioned who would decide if those programs were equivalent to a NAAB accredited degree with additional education. After more discussion, Mr. Nolasco suggested the Board needed a lot more information to make an informed decision on what direction to take.

Following the voting on the investigative and licensure cases, the Board reviewed standing committee reports, old business, and then adjourned.



File A FORMAL COMPLAINT

The Kentucky Board of Architects was established by an Act of the Kentucky General Assembly in 1930 to protect the public health, safety and welfare by the regulation of architects. Since July, 2002, the Board has additionally assumed the responsibility for the certification of interior designers in the Commonwealth. Online Proctoring Tips

If you're preparing to take an exam via online proctoring, keep in mind that <u>you</u> are responsible for ensuring your testing environment meets NCARB and PSI's technical and environmental requirements.

This includes:

- Using an external webcam: You cannot use your laptop's integrated webcam to take the ARE.
- Closing other software while testing: During the exam, you should not use your web browser, check email, or open any other software applications.
- Establishing a strong internet connection: Plan to use an ethernet connection (not Wi-Fi) to minimize connectivity-related disruptions.

ARE CANDIDATE TIPS

Architectural Experience Program (AXP)

NCARB offers a variety of experience opportunities that qualify for AXP credit outside of typical architecture work. To qualify for AXP credit, your work must fit into one of two experience settings. These settings provide details about the type of organization you work for, the tasks you perform, and who verifies your experience. You can earn up to 1,860 hours of AXP credit while working under the supervision of an individual who is licensed to practice landscape architecture, engineering, or as an architect outside the United States. If you are not currently working for an architect or architecture firm, this category allows you to earn up to 320 hours working in design or construction-related employment. Only employment and experience that aligns with the AXP tasks can qualify for AXP hours. In addition, you can report experience older than eight months and up to five years in the past for partial AXP credit.

Design or construction-related activities qualify under the direct supervision of a person experienced in the activity of:



- · Analysis of existing buildings
- · Planning
- · Programming
- · Design of interior space
- · Review of technical submissions
- · Management of building construction activities

ARE Exam Changes: ICC Code Update and QFIB Retirement

NCARB works regularly with psychometricians and hundreds of volunteer architects to ensure the Architect Registration Examination® (ARE®) aligns with exam best practices and current architectural practice. As part of the ongoing efforts to improve the ARE, NCARB implemented two updates that went into effect on February 27, 2024:

- 1. All code-related items on the ARE will reference the 2021 International Code Council (ICC) family of codes and related standards, rather than the 2018 family. When necessary, NCARB will provide excerpts from the 2021 ICC family of codes as references on case studies. You can view a summary of significant code changes from IBC 2018 to IBC 2021 in the ICC I-Codes. If you are interested in a deeper explanation of the changes, watch the American Wood Council's two-part video series.
- 2. NCARB has also retired quantitative-fill-in-the-blank (QFIB) item types from the exam. NCARB strives to align with evolving test practices, which indicates that other item types used on the ARE assess candidates' qualifications.

ARCHITECT INFORMATION

FIRST TIME RENEWAL FOR NEWLY LICENSED ARCHITECTS

Continuing Education Hours (CEH) are required as a condition for the annual license renewal. A minimum of 12 CEH shall be acquired during the period beginning January 1 and ending December 31 calendar year directly prior to the annual renewal. All 12 CEH's shall consist of structured educational activities on relevant topics addressing health, safety, and welfare subjects as referenced in 201 KAR 19:087, Section 1(3).

For the Annual Renewal period held June 1 - June 30, 2024 the architect is required to certify that they obtained the required 12 HSW CEUs between the dates of January 1 - December 31, 2023.

Example 1

If an architect becomes licensed in Kentucky between January 1 and June 30th, the newly licensed architect must get 12 CEH's between their <u>initial date of licensure and Dec 31 of that same year</u>. The newly licensed architect is exempted from reporting having earned the required CEH's during their first annual renewal period, which is between June 1 to June 30 of the year they were licensed, but they will be required to have met the requirement on their second renewal. An individual licensed on 03/15/2024, will be required to renew their license by 06/30/2024, but will not be required to have 12 CEH's earned 01/01/2023-12/31/2023. When this individual renews the next year by 06/30/2025 they will be required to have earned 12 CEH's between 01/01/2024-12/31/2024.

Example 2

If an architect becomes licensed on or after July 1, the newly licensed architect must get 12 CEH's <u>between</u> <u>January 1 and December 31 of the following year.</u> The newly licensed architect is exempted from reporting having earned the required CEH's during their first annual renewal period, which is between June 1 to June 30 of the year following their initial licensure, but they will be required to have met the requirement on their second renewal. An individual licensed on 08/15/2024, will be required to renew their license by 06/30/2025, but will not be required to have 12 CEH's earned 01/01/2024-12/31/2024. When this individual renews the next year by 06/30/2026 they will be required to have earned 12 CEH's between 01/01/2025-12/31/2025.

UK GRAY BUILDING UPDATE

Students and faculty have just moved into the renovated and transformed former Reynolds warehouse, realizing their dream for the College of Design, at the new Gray Design Building. Partnered with Studio Gang Architects, KNBA Architects, along with CMTA Engineers, Brown + Kubican Engineers and Carman, transformed this 107-yearold brick and heavy-timber building into a cutting-edge design, making, and collaborative teaching space.

The new facility focuses on deliberate,

modern architectural elements within the building while also purposefully maintaining the warehouse aesthetic. A new sculptural steel "Clearing Stair" is the focal entry point and circulation hub. Open plan Studios create a cross-disciplinary environment for the multiple design programs.

On the exterior a weathering steel canopy has been installed along the South façade, creating an outdoor fabrication dock, directly connected to the Fabrication Shop, as well as being an environmental canopy reducing solar heat gain.

Removed from the campus boiler and chilled water system, this is the University's first fully geothermal supported building. All windows were replaced with historically accurate, operable units. The site was upgraded for outdoor learning and teaching spaces. The 3-story, 135,000 square foot facility was completed by Construction Manager, Turner Construction, for \$49 million in the Spring of 2024.

L. Wayne Tune Endowment Scholarship

Congratulations to Austin Olah for being awarded the 2024 L. Wayne Tune Endowed Scholarship. He is currently employed by Brandstetter Carroll Inc. as an Architectural Intern. In 2016, he graduated from the University of Tennessee with a Bachelor of Science degree in Business

Need to change your legal name in NCARB?

Your legal name MUST match the name listed on your ID or you will not be permitted to take the ARE exam. Here's how to get started:

Log in to your NCARB Record

- 1. Navigate to the "Profile" tab in your Settings
- 2. Click "Change My Legal Name"
- 3.Confirm your contact information is correct, so we can reach out to you regarding your request if needed
- 4.Enter your updated legal name
- 5.Upload a copy of your state-issued ID and legal name change document (such as a marriage certificate or divorce decree) to support your request

Have a preferred name that's not your legal name? You can update your preferred name in your My NCARB Settings at any time. NCARB will use your preferred name when reaching out to you via email or on the phone, although your legal name will still show on Record transmittals, exam appointments, or any other legal documents.

WIGWAM VILLAGE NO. 2

Historic Wigwam Village No. 2 in Cave City, Kentucky, was built in 1937. It has been a popular roadside attraction for over 87 years. It is one of only three surviving Wigwam Villages of the seven built in the country before 1950. It is also listed on the National Register of Historic Places. Wigwam Village was described as: "one of the most historic



forerunners of a practice now known as place-product-packaging the commercial use of architectural imagery by automobile service-oriented establishments along the American roadside" by the National Register of Historic Places. It started with Kentucky native Frank Redford. He was traveling across the country and saw a barbecue restaurant shaped and painted like a teepee. When he returned home to Horse Cave in 1933, he opened a lunch counter and gas station painted similar to a teepee. In 1935, he expanded his business to six concrete teepees for over-night lodging. Mr. Redford called structures wigwam and they were made of steel and wood framing covered in stucco. In 1936, he patented the design construction and also in 1957 when his first patent expired. The teepees are arranged in a semicircle facing a big grass bowl at the center to encourage people staying there to gather around the fire pits as children play in the nearby playground.



AWARENESS AND ACCESSIBILITY ON LICENSURE PATH

NCARB recently released their report concerning disparities on the path to licensure. The survey findings are demonstrated below:

- 1. Most licensure candidates are not sufficiently aware of the licensure process at an early career stage, which would benefit them in making informed choices about factors like what degree to pursue or where to pursue licensure.
- 2. Most licensure candidates had to change their licensure path at some point and felt like the licensure process was not flexible enough to accommodate their shifting personal or professional circumstances.

WHAT IS THE SETTING O?

Setting O involves additional experience opportunities that can be performed outside an architecture firm or while working for an architect licensed in a country other than the U.S. or Canada. A few of these opportunities allow you to gain AXP experience while unemployed or working in a related field. There is no minimum number of hours required for this experience setting, although each opportunity has a maximum limit.

Please be advised that paid academic internship that meets all the requirements for a specific setting O work opportunity, *you can report relevant experience for AXP credit* in the same way as any other setting O experience. You do <u>not</u> need to identify academic internships or have them pre-approved by NCARB.

Maximizing the Value of Employee Compensation

With 2023 in the rear-view mirror, firms are evaluating what went right, what went wrong, and what they can do better for 2024. Many in our industry are struggling with employee retention and a corresponding labor shortage; they're wondering what they can do to maximize employee benefits and make themselves as attractive as possible.

For the purposes of this article, we're going to pretend that we're a mid-sized architecture firm organized as a C corporation. We have five shareholders and ten employees, each single and making \$100,000 per year on their W-2s. At the end of the year, we have enough extra cash to pay out \$4,000 to each one of the

year on their W-2s. At the end of the year, we have enough extra cash to pay out \$4,000 to each one of them. How can we get the biggest bang for these bucks?

First, let's summarize the taxes that could apply in this situation:

	Lexington/Fayette tax	Federal tax	Kentucky tax	FICA
Employ <u>er</u>	2.75%	21%	5%	7.65%
Employ <u>ee</u>	2.75%	24% (given their income level) 15% (for dividends)	4% (for 2024)	7.65%

Scenario 1: Bonus pay

This is probably the most common scenario. The company pays out a \$4,000 bonus through payroll. With the tax rates listed above, **the employee will net \$2,464 after taxes**. The employer will pay out \$4,306 (the bonus plus their FICA portion), but they will get to deduct this expense against their own taxes, saving them \$1,238 in tax. So the net total cost to the employer is \$3,068 – still more expense than the employee's net.

Bottom line: commonly done but mediocre result for both employee and employer.

Scenario 2: Dividends

This scenario would only apply to the shareholders of the corporation, but it ends up being more beneficial to the employee shareholders because they get a favorable Federal tax rate and they avoid both local taxes and FICA. After Federal and state taxes, the \$4,000 **dividend would net to \$3,240** – nearly \$800 more than in the scenario above. It is not as favorable to the employer, however, because they cannot deduct the dividend; so their total outflow remains \$4,000.

Bottom line: shareholder employees love it; corporations do it to return value to shareholders but don't get a tax benefit.

Scenario 3: 401(k) Plan

A traditional (non-Roth) 401(k) plan allows you to defer Federal and state taxes until retirement. So although this scenario will not show Federal or state taxes for 2024, bear in mind that those taxes will eventually be paid when distributions are taken in retirement.

The first option is that the employer could give the employee some extra pay and the employee could elect to contribute that money to a 401(k) or SIMPLE IRA. In this case, they would pay FICA and local Lexington tax, but not Federal or State, making their **net amount \$3,584**. Since the employer paid this cash to the employee, the employer's tax impact would be identical to scenario 1.

The second option, however, is to consider an employer contribution or match. This is where the employer contributes to the retirement plan directly instead of the employee deferring part of their paycheck. In this case, the employee pays no current taxes at all on the amount, **netting them the entire \$4,000**. The employer also gets to deduct the full \$4,000 and pays no FICA on it. Their tax savings from this deduction are \$1,150, giving them a net total cost of only \$2,850.

Bottom line: great result for retirement savers and employer match is a no-brainer.

Scenario 4: HSA Contribution

If the firm has an HSA (health savings account) plan, it is one of the most tax-advantaged vehicles available to taxpayers. Not only is it exempt from both Federal and state income taxes, unlike 401(k) contributions it is also exempt from FICA if processed through payroll. And while you're limited to using it for qualified medical expenses when you're young, you can start using it like an IRA when you turn 65 (meaning you can use it for anything if you pay normal income tax on the distributions, same as you would with other retirement accounts).

The first option is that the employer could give the employee some extra pay and the employee could elect to contribute that money to their HSA (if they have not maxed it out yet). In this scenario, they would only pay local Lexington tax on the income and **net \$3,890**. The employer also pays no FICA, gets to deduct the entire \$4,000, and has a net cost of only \$2,850 after tax savings.

The second option is for the employer to make the HSA contribution directly on behalf of the employee. The only difference here is that local tax is also avoided, allowing the employee to **net the entire \$4,000**. And the employer's deduction is the same as above.

Bottom line: if you have space left in your HSA, definitely max it out through payroll each year.

Although these scenarios are dependent on the specific type of firm outlined for this example, hopefully they give you a sense of how fringe benefits can have varied impacts, especially as the dollars amounts involved get larger. Not all employees want the same thing, but being smart about the form of compensation you offer can lead to tax savings in the long run. Consult with your tax advisor about your firm's specific situation, goals, and needs throughout the year and make 2024 your best year yet.
