# NCARB NEWS

## NCARB COMMITTEE SUMMIT OKLAHOMA CITY, OKLAHOMA

The NCARB Education Committee met in September and December 2019 to discuss potential changes to the NCARB Education Standard in light of NAAB's draft revisions to the NAAB Conditions and Procedures for Accreditation. At the September meeting, committee members reviewed draft revisions to the NAAB Conditions and Procedures for Accreditation, providing comments to the NCARB board, which were shared with the NAAB.

Also in September, the committee appointed a writing group to begin the work of adapting the Education Standard. The writing group recommendations were reviewed at the December 2019 meeting by the committee as a whole, with additional comments incorporated into the draft revised Education Standard. The final committee recommendations will be transmitted to the NCARB Board of Directors for review at their January 2020 meeting.

The Education Committee has also been discussing the IPAL (Integrated Path to Architectural Licensure) program and ways to increase IPAL adoption. Currently, twenty-one schools across the country have established an IPAL option for students (<https://www.ncarb.org/become-architect/ipal>).

## CIDQ ANNUAL CONFERENCE HIGHLIGHTS

Approximately 100 delegates and representatives from the US and Canada attended the Conference to discuss CIDQ, the NCIDQ Exam and issues related to the interior design profession as a whole. It was a positive experience to exchange ideas and tools for regulating Certified Interior Designers.

Thom Banks, CEO of CIDQ, reported that 2019 was another positive year. They conducted an audit of item bank (exam questions), updated the definition of the profession, conducted a practice analysis, enhanced the graphic quality of the examination and digitized and uploaded 22,000 hard copy documents to certificate holders' records.

Bill Bouche, Principal/Director of Design, Interiors at HOK gave a thought-provoking presentation on "Moving Beyond Core Competencies" that focused on improved communication and story-telling skills throughout the design process. Michael Wirtz received the 2019 Tregre Award for his outstanding contributions to CIDQ and the profession.
